Dear Inspector Timoney and Inspector Iocco:

I write on behalf of constituents who are concerned by two recent events that occurred at Broadway shows on February 15, 2020 and December 23, 2019. On February 15, 2020, an audience member discharged pepper spray at the matinee performance of "Jagged Little Pill" at the Broadhurst Theatre, and on December 23, 2019, an individual ran into the Gershwin Theatre, pushed past ticket takers, and stormed on stage during a performance of "Wicked" and had to be restrained by crew members until the police arrived several minutes later.

In light of these two recent security breaches, I request that more NYPD officers be added to the Theatre Squad and that Theatre Squad patrol on Sunday and Monday evenings, as they do on other days of the week. I understand that The Broadway League has been working with all of the theatres in the Theatre District to improve security operations. To further this effort, I also request that Manhattan North and Manhattan South consult and collaborate with theatres in the Theatre District and The Broadway League on best security practices. Lastly, I request that NCOs reach out and work closely with the theatres in their respective sectors.
